## A study of Maine's horizontal date hand cancels to date

In the Beginning

om and I have never met personally. While posting messages on an Internet message board, we discovered that we both had an interest in postmarks in general and Maine in particular. We were intrigued by the newer Maine hand cancels which had shorter and thicker bars than some of the older types. To determine how widespread the use of these cancels were in Maine, we decided to send requests for hand cancels to every post office in the state, asking for cancels from one of their hand cancellers. Tom started with "A" and worked forward. I started with "Y" and worked backward.

The response from the postmasters in this state was excellent. There are more than 400 post offices in the state and we have received hand cancels from nearly all of them. Approximately 50 percent of the returns were horizontal date cancels (or HDC as we now call them). The ratio of horizontal date cancels versus the number of total hand cancels was interesting because we didn't know what to expect.

Almost immediately we noticed that many of the HDCs had differing lengths of killer bars. Determining what was a normal length killer bar and what was a variation proved to be frustrating. A killer bar length is dependent on several factors: the age of the handstamp, amount of pressure applied and even the manufacturer. While comparing several covers for killer bar length, Tom realized that all the short killer bar cancels had horizontal date lines regardless of kill bar length. Further investigation into my own covers corroborated Tom's findings. We then decided we could simplify cataloguing the information by changing the project name to Horizontal Date Cancels. By changing the name to HDC we did not need to consider kill bar length as a variation.

While studying our returned covers, we determined that there were three distinct types of horizontal date cancels. In addi-

tion to the single circle, there is the double circle and the double circle with the inner circle split into an upper and lower arc. We have also recorded 20 variations. Each cancel type shares some variations and some variations are unique to each type of cancel.

#### **Types and Variations**

The three cancel types are thus explained. Type 1, the most popular, is a single circle. Type 2 is a double circle. Type 3 is a double circle with the inner circle split into two arcs. Information contained in the cancels are town name, ZIP code and month-day-year date line horizontally across the center. There

## Contract Postal Work 1828-1833

hose who work to document postmaster appointments, delving in old records and straining to read microfiche, occasionally are fortunate enough to come across a piece of original documentation in our own holdings: a postmaster appointment, a certification of bond established, or a record book from a post rider. Recently, in preparing for a talk on the District period of Maine history, I opened a box I had not opened since our move three years ago, and found something of interest. I thought my fellow MPS members might be interested in the contents. Input is sought by the author.

The first item is a printed notice from John McLean, Postmaster General, and dated 26th July 1828. Sent under free frank from Washington City to Augustine Blake, Esq., Monmouth, ME, it requests an accounting of the number of horses, drivers and carriages used in transporting mail on each route, including those where only riders and horses are used.

In the same box were two responses regarding Mr. Blake's performance, addressed to PMG John McLean.

Mr. Augustine Blake has transported the U. S. mail from Monmouth to Paris for nearly two years last part, & to the best of our knowledge to the satisfaction of public. Believing him to be a faithful & meritorious agent of the department, we cheerfully & cordially recommend him to your notice.

Sept 15, 1828.

There is nothing in my holdings which indicates the response to PMG McLean from Mr. Blake.

In the Report to the House of Representatives for the year ending 31 March 1827, these offices are recorded with the following statements of net postage accrued.

The Register of Officers and Agents on the 30th of September, 1831 lists "Augustin Blake" as a contractor with compensation of \$102. So apparently the letters of recommendation had the desired effect for Mr. Blake.

However, not all the postmasters are the same in this report. In the 1831 Register, the income levels and four postmasters have changed (indicated with an \*).

Another document, datelined Waterville, 28th Apl. 1832, also addressed to the PMG, deals with part of the same route.

Sir

Doct. Hall Chase has shown me a letter from your department stating that the contractor on the route from Waterville to Monmouth must be detained at Waterville until the arrival of the Western mail; my contract is for a jig mail 25 miles and is to leave Waterville at 7 o'clock A.M. & arrive at Monmouth at 6 o'clock P.M. and is contracted to drive through without a change of horses and with a single horse the pay on said route will not afford additional team; the mail arrives at Waterville from the West usually from 9 o'clock to 12 A.M. nearest the latter, doing the bad travelling. Now it will be nearly or quite inpracticable to fulfil (sic) my contract in arriving at Monmouth on [?] time; no time is fixed I understand, for the arrival of

are numerous variations. For example, nine digit ZIP code versus five digit, AM or PM added, small number ZIP, comma after town name, etc. Illustrated data sheets are being maintained for each type which includes the type description as well as known variations for that type. A master list of all variations is also being maintained and updated as needed. A data sheet, which lists the towns with HDC, the cancel type and variations, is being continually updated as new information becomes available.

#### Manufacturers/Distributors of HDC

Attempting to determine the manufacturers/distributors of these cancellers has proven to be difficult. One has to actually see the canceller or get the information from post office personnel. From information received thus far, it is obvious that the number of different hand canceling devices could be a very large number. For this reason, we decided not to catalogue cancels versus canceller manufacturer.

Some information was gained through Internet search, other information was provided by postmasters and window clerks. Following is the information we have at present for manufacturers/distributors, brand names and cancel types.

#### **Future Plans**

We will continue to look for additional offices using these cancels and for additional variations on the three types identified so far. We intend to keep the project current and issue updates periodically. We also solicit help from collectors and other interested parties so that we may continually update the cancel information and make it available to all who want to have it.

Following is a synopsis of the three basic types with notes about variations:

## Maine Cover of the Quarter


A postal history feature by Rob Washburn of Skowhegan




The odds are certainly not in favor of getting TWO different plate number coils on one commercial cover, but the above cover sent by a Bangor lawyer to a Skowhegan court shows such an unusual coincidence. As you can see from the enlargement (lower right of cover), the 17¢ Electric Auto coil has a plate number 3 at bottom and the 20¢ Flag coil has a plate number 9 at bottom. Only one out of 24 stamps in a roll of 17¢ Electric Auto coils has a plate number, and only one out of 48 stamps in a roll of 20¢ Flag coils has a plate number, making the odds of this combination of both coils appearing as PNCs on one cover only 1 out of 1,152!

This photo, taken from a post card, shows the post office at Beachwood in the early 1900s. If you haven't heard of Beachwood, it was in Kennebunkport in York County, and was a summer office. the Western mail at Waterville it arrives at Norridgewock 15 or 20 miles above (according to the route) at 6 o'clock P.M. which gives ample time from Waterville after 12 o'clock M When the Monmouth or my mail leaves Waterville at the hour, 7 o'clock A.M. It arrives at Winthrop in season to meet the Western mail on its route to Augusta through Monmouth and Winthrop; - thus offering facilities for the towns of Belgrade, Mt. Vernon, Readfield to forward their communications earlier than they otherwise could do, or if the mail is detained at Waterville latter this could not be

I wish instructions from the Department on this subject. I wish to know the construction that is given to my contract by the Department. And if alternatives are to be made in the time of departure, a corresponding alteration in the time of arrival should in justice be made otherwise it would seem just GENERAL POST-OFFICE DEPARTMENT.

26th July, 1828.

SIR.

I am desirous of ascertaining the number of carriages, horses and drivers employed in the transportation of the mail on each of your routes, and the number of horses and of riders employed on each route, where horses only are used.

In your answer, please designate the route by its number, and the places of its beginning and termination.
